Rental Terms and Conditions

THE BOOKING :

Book by post, fax, phone and on the website www.camping-lescypres85.com

Deposit for reservation: - 30 % of your stay + booking fees (25 € in high season or 10 € in low season).

A booking will be treated with a completed booking form (in full). Only persons listed on the booking form are permitted to enter the campsite. Any changes to the contract must be reported in advance in writing and shall be final only after written agreement of management. Any additional person may be unreported denied access to the campsite. The booking is final once it has received written confirmation from us, (and must be presented on the day of your arrival). The balance of your stay must be paid upon arrival. Reservations not transferable to another party.

PRICING :

They include: rent a camping pitch or accommodation (for the number of persons indicated), the supply of gas, and electricity for the accommodation, access to the pool and paddling pool, the playground multisport at petanque, sanitation common to the ironing room, and some activities. - They do not include: application fee, city tax, some specific activities and optional, the textile rental, provision of sheets, cleaning the rental in case of unsatisfactory cleanliness at departure (90 € penalty on your deposit will be retained).

RENTALS

A deposit of 200 € will be asked on the day of your arrival, in guarantee of a restitution of the accommodation in good state, a restitution of the accommodation in perfect state of cleanliness.

A control of the accommodation is carried out before each arrival by the staff of the campsite. We give you on arrival a checklist to fill out and return to the reception within 24 hours. The day of your departure, we ask you to respect the instructions (clean the house, defrost and clean the refrigerator, clean and wiped dishes ...). The day before your departure, you will be asked to make an appointment to agree on the time of the inventory of places of exit. A campsite staff will check your rental, and deposits will be returned (July / August)

CHANGES AND CANCELLATION OF STAY :

The campsite manager must be notified of any delay in your arrival in order to retain your rental location or Hosting. No news from you 20 hours before the day of your arrival, it reserves the right to dispose of your rental without you can claim any refund of amounts paid. No refunds and no reduction shall be granted in the case of late arrival or early departure, for whatever reasons. Bookings are, it is forbidden to sublet or assign to third. Any amendment to the contract must be notified in advance in writing and becomes effective only after approval of the manager. In case of declaration inaccurate, the contract will be automatically terminated and payments will remain the campsite. For cancellation, the deposit will be refunded under any circumstances if you have not subscribed to the cancellation insurance. In all cases, the fees remain the campsite. The subscription cancellation insurance is recommended. The amount is payable in full and only when booking. (15 € In Rental week or 15 € for a camping trip.) Reimbursement will be made as follows: Cancellation: more than 30 days before arrival: 100% the amount paid *. Cancellation: more than 15 days before arrival: 50% of the amount paid *. Cancellation: less than 15 days before arrival: 25% of the amount paid *. (* After deducting fees and

cancellation insurance and the receipt of a letter of cancellation). Failure to observe the internal rules at the campsite can justify the termination of the right and the sums paid remain the campsite.

ANIMALS :

The 1st category dogs are strictly prohibited. Only cats and dogs (on leash), tattooed and vaccinated (including rabies) are accepted a limit of one per site (vaccination card required).

SHOOTING, VIDEO :

We may need to take your picture to redo our advertising, if you do not want should notify us by mail recommended prior to arrival.

VISITORS :

Visitors are required to report to reception before entering the camp and leave their vehicles in the parking lot at the entrance. They are the responsibility of the campers who receive them. No royalty is required, however they are not allowed to access the pool.

EXTRACT FROM THE RULES :

Silence: The movement of motor vehicles is limited to 10km / h and is prohibited in the campground between 23h and 7am (access doors are closed between these hours). The use of sound equipment must not be audible beyond the perimeter of the plot. From 23h, it is everyone must respect the right to rest of its neighbors. Pool: The shorts are strictly forbidden, wearing a bathing suit is required. it is forbidden to drink or smoke in the pool enclosure.
